GENERAL INFORMATION:

MicroVite is designed as a source of Sulfate Sulfur, Zinc, Copper, Manganese and Magnesium to treat or prevent deficiencies for all field, row, vegetable, fruit, tree, vine, ornamental and turf crops.

CONTAINS NON-PLANT FOOD INGREDIENTS: Amino Acids, Enzymes, Vitamins and DeltAg Proprietary Complexing Agent.

MicroVite may be

- Foliar applied alone or with pesticides
- Used in drip irrigation systems
- Applied to soil via conventional methods

APPLICATION RATE:

Side-Dress: 32 ounces per acre.

Seed Treatment: Not Recommended.

In-Furrow: 32 ounces per acre.

Foliar: 32 ounces per acre.

Apply in a minimum 5 gallon volume for ample coverage. **As much as 64 ounces per acre may be applied where deficiencies are observed.

Drip Irrigation: Apply one-third (0.33) ounce per 1,000 square feet of foliage weekly as needed.

Injection at 1 to 100: Add 6 ounces per gallon of mix tank water (468 ppm of product) weekly as needed.

COMPATIBILITY: This product is compatible with most commonly used pesticides. However, it is advisable to always check for compatibility.

NOTE: Always follow label directions and precautionary statements on pesticide label.

CAUTION: KEEP CONTAINER TIGHTLY CLOSED AND OUT OF REACH OF CHILDREN.

STORAGE AND DISPOSAL:

Do not contaminate water, food or feed by storage or disposal. Follow all governmental procedures for the disposal of pesticide spray solutions. Triple rinse container; empty rinsate into spray tank. Dispose of empty container according to approved local practices.
